Educational aims of the course

To develop graduates equipped with the necessary skills and qualities to take roles within the Civil Engineering industry as professional engineers, and to provide an educational foundation upon which graduate engineers can build with further learning and experience in order to achieve higher professional status and responsibility.

The core elements of UK Standard for Professional Engineering Competence (UK-SPEC) are embedded in the programme learning outcomes. These are interpreted in the context of Civil Engineering as the following six key areas of learning:

• Science and mathematics (SM)

Understanding of mathematical methods appropriate to civil engineering and construction. Scientific principles underlying civil engineering and construction.

• Engineering analysis (EA)

Application of mathematical and engineering principles in the solution of practical problems relevant to civil engineering, including the use of software packages.

• Design (D)

Principles and practice of the design of solutions in civil engineering Assessment of alternative solutions Specification of final design.

• Economic, legal, social, ethical and environmental context (ES)

Knowledge of the business and management practices in the construction industry including personnel, health, safety and risk issues and sustainability and environmental considerations.

• Engineering practice (EP)

Investigation of cutting edge practice in civil engineering including fieldwork, laboratory skills, and materials Project planning management and implementation. Awareness of quality issues. Working effectively as part of a team and individually to achieve goals and develop responsibility and management.

Additional general skills (AS)

Understanding of professional and ethical responsibility of Civil Engineers. Effective interpersonal and communication skills. General skills for enhancing professional and career development.
